

# BreakThru Student Retreat 2011

## Covenant Session One

I understand the need to be responsible on this trip and follow these specific guidelines. I realize my actions may affect the safety and the unity of the group on this trip.

### Guidelines

1. I understand I should respond and do things asked of me by the leadership.
2. I understand I must be on time for all events.
3. I understand that I must adhere to the following rules:
  - No being out of the cabin/room after curfew for any reason.
  - No boys in girl's rooms or girls in boy's rooms for any reason.
  - No use of vulgar language or profanity
4. I understand that the following is not accepted in any form:
  - Willfully vandalizing, in any way, the property of the camp, BreakThru Ministries, or property owned by others.
  - Intentionally damaging another's personal property.
  - Cruelty to or intimidation of another student.
5. I understand that I am not to engage in any gambling activities or perceived gambling activities.
6. I understand that I am not to enter any body of water at any time.
7. I understand that I'm not allowed to POSSESS or USE tobacco, alcohol, any other type of drugs or drug paraphernalia. No fireworks or weapons are allowed. Pornography, in any form, is not allowed.

### Consequences

For breaking guidelines 1-3

These actions will be confronted once and, if repeated, privileges will be lost.

For breaking guidelines 4-6

These actions will result in your parents being called to inform them of the violation.

For breaking guidelines 7

These actions will result in immediately being sent home at family's expense.

### Commitment

I give the BreakThru Ministries staff the right to enforce consequences for reasons that may not be in this covenant, but are negative and/or detrimental for the ministry, group, and/or trip. If my/our son/daughter chooses to not honor the guidelines, I realize they will be sent home at my/our expense. I/We have discussed these guidelines with my/our child, and am/are confident he/she will honor these guidelines and the BreakThru Ministries leadership.
